Regd **VP-KAA** [CofR 1] 3.1.29 to same owners. Regd [12.36] [CofR 1] to DAG Onslow, Njoro. Reportedly donated to RAF as "museum piece" 9.51. Handed back by RAF Authorities. Regd (CofR 1E) 24.9.55 to JS LePoer Trench & partners, Westlands, Nairobi. CofA renewed 27.1.56. CofA lapsed 3.3.62. Regn cld [3.66].
- VP-KAB Fokker F.XI Universal [422] ex **G-EBUT** Regd 5.2.29 [CofR 2] to John E Carberry; named "Miss Africa". To **G-EBUT, VH-UTO**.
- VP-KAC DH.60G Moth (1004) Regd 2.7.29 (CofR 3) to Mrs FK Wilson & Tom Campbell Black, Nairobi; dd 5.7.29 to Wilson Airways; named "Knight of the Mist". Crashed from stall turn and destroyed by fire Nairobi 4.8.35; pilot AJ Master injured and passenger badly burned. Regn cld 3Q.35.
- VP-KAD Westland Four [WA.1897] ex **G-AAJI** Regd 26.11.29 for Wilson Airways Ltd; not taken up. Regn cld 16.1.30 as "wrong information given". Completed as Westland Wessex P.1, later **G-ABAJ** 5.30.
Note – no connection between this regn and Avro Ten c/n 371. Confusion because VP-KAD quoted the CofA No. for the Westland IV as 2316 [which was the Avro Ten] rather than the correct No.2310.
- VP-KAD" Avro 619 Five [436] [UK CofA 2373 issued 22.1.30] Regd 16.1.30 [CofR 7] to Wilson Airways Ltd, Nairobi; named "Knight Errant". Scrapped Nairobi 10.32. Regn cld 1.33.
- VP-KAE Avro 619 Five (228) [UK CofA 2259 issued 3.10.29] Regd 30.10.29 (CofR 5) to Wilson Airways Ltd, Nairobi; named "Knight of the Grail". Wfu 10.35 (also quoted as cx/sold UK 7.10.35).
- VP-KAF DH.60M Moth (1426) [UK CofA 2287 issued 31.10.29] Regd 30.12.29 (CofR 6) to Aero Club of East Africa, Nairobi; presented to Club as a gift by Sir Charles Wakefield and named "Acea" by Lady Grigg [wife of Governor of Kenya] 5.1.30. Crashed; regn cld 1.36. Rebuilt as **VP-KBZ**.
- VP-KAG DH.60G Moth (1137) ex **G-AALD** Regd 6.3.30 (CofR 8) to Mrs FK Wilson, Nanyuki; initially as personal aircraft but later t/a Wilson Airways; named "Blenny". Crashed 9.2.33 and regn cld. Rebuilt (possibly with new fuselage) and regd 11.5.34 to same owner. Crashed on take-off Nairobi 17.11.35; repaired. Crashed .38; rebuilt. Impressed into KAAU as **K23** 9.39. Crashed 24.6.42.
**In 11.38, E Atkinson of South Africa attempted to register c/n 1137, saying that he had purchased the remains from Wilson Airways in 1936 and was rebuilding the Moth. Nothing further known and regn presumed not progressed.*
- VP-KAH" Avro 619 Five [383] ex **G-AASO** Reservation 8.30 for Wilson Airways Ltd. NTU and remained as G-AASO. [G-AASO regd 5.9.30 to Wilson Airways Ltd; dbr in Rhodesia 18.1.32 & UK regn cld 10.32].
- VP-KAH" DH.80A Puss Moth [2061] ex **G-AAZS** [NTU] [UK CofA 2702 issued 25.8.30] Regd 9.10.30 to Wilson Airways (but flown as VP-KAH at Hamble Garden Party 31.8.30 by Wilson's MD Tom Campbell-Black). Used for Africa-England route survey by Marthinus CP Mostert 24.2.31 to 12.4.31 from Zanzibar to Nairobi, picking up Mrs Wilson and thence to Gao, Bathurst, Las Palmas and Madrid to England. Regn cld 22.4.31 as returned to De Havillands in exchange for VP-KAM c/n 2153. Regd **G-ABNV** [CofR 3276] 6.31.
- VP-KAI DH.60M Moth (1669) [UK CofA 2844 issued 8.12.30] Regd 21.2.31 (CofR 10) to Shell Co of East Africa Ltd, Nairobi. Regn cld 2Q.35. Regd in UK as **G-ADEZ** 3.35.
- VP-KAJ Daimler Klemm L20-BI (38) ex **D-1298** [see below] Regd 23.12.30 (CofR 11) to T Deas, Nairobi. Regn cld 8.33 as wfu.
Note – also quoted as c/n 48 and both were regd in Germany to Africana Handels GmbH, Hamburg. D-1285 c/n 38 & D-1298 c/n 48 – both cld 6.29 as sold abroad.
- VP-KAK DH.80A Puss Moth (2118) [UK CofA 2898 issued 7.2.31] Regd 30.3.31 (CofR 11 – number duplicated above) to Wilson Airways Ltd, Nairobi; named "Knight Crusader". Delivered by air from Croydon by (Wilson's MD) Tom Campbell Black, departing 6.3.31. Flown by Campbell Black from Nairobi-Entebbe-Kisumu-Mombasa-Zanzibar-Dar-es-Salaam-Nairobi 8.7.31 (1600 ml record). Regn cld 5.37 as sold in **Tanganyika** [but not locally regd]. Regd 4.6.37 to JAR King, Dar-es-Salaam [still as VP-KAK]. Returned to UK .38. Regd **G-AFKV** 9.11.38.
- VP-KAL DH.60G Moth (1108) ex **G-AAJV** Regd 25.4.31 (CofR 12) to Wilson Airways Ltd, Nairobi. Regn cld 23.11.32 as reduced to spares (possibly after accident?).
- VP-KAM DH.80A Puss Moth (2153) [UK CofA 3008 issued 30.4.31] Regd 24.4.31 (CofR 13) to Wilson Airways Ltd, Nairobi. Regn cld 22.6.34 on sale to JG Waime, **Belgian Congo**. No interim regn known. Sold to Kenya 14.3.35. Regd **VP-KBI** 20.4.35 to L Kaplan, Nairobi.
- VP-KAM *Erroneously reportedly reserved 14.5.31 for DH.60G Moth G-ABAK [1265] owned by Capt The Hon Denys G Finch-Hatton, Stag Lane but which overturned on take-off Voi, Kenya 14.5.31 and dbf; Finch-Hatton and native servant passenger killed. Error due to adjacent report in Kenyan return to London referring to DH.80A VP-KAM.*
- VP-KAN Avro 616 Sports Avian IVM [424] ex **G-ABEA** Regd 29.10.31 [CofR 14] to Mrs Beryl M Markham, Rongai [regd in Kenya as G-ABEA, so Kenyan regn possibly NTU]. Regd 20.1.36 [CofR 14] to JE Carberry, Nyeri. Reregded **VP-KBY** .36.
- VP-KAO DH.60M Moth (1555) ex **G-ABCZ** Regd 8.31 (28.9.31?) [CofR 15] to Mrs Helen Silver, Nairobi. Sold .31 to AN Turner. Sold .31 to John E Carberry, Nyeri. Regd 4.32 (CofR 15) to WR Carr, Nairobi. Regn cld as sold 4.32. Regd **VR-TAH** 10.5.32 to Tanganyika Airways Ltd, Arusha.
- VP-KAP Waco CSO (3206) ex **ZS-ABZ** Regd 4.32 (CofR 16) to SN Turner, Nyeri, Kenya. Regd 18.10.35 [CofR 16] to East African Airways Ltd, Nairobi. Impressed as **K1** 9.39.
Reported on Kenyan register at 8.31.
- VP-KAQ DH.60G Moth (1807) ex **G-ABGY** Regd 3.2.32 [CofR 17] to Miss Aline Barton, Nairobi. Regd 5.4.32 (CofR 17) to R Ussher, Nyeri. Crashed Nyeri 17.7.32. Regn cld 1.33.
- VP-KAR DH.60GIII Moth (5004) ex **G-ABWT** Regd 24.9.32 (CofR 18) to Henry W Sear, Nairobi. Regd 29.5.33 (CofR 18/2) to George Blowers, Nairobi. Regd 29.7.35 to CH Edwards, Kakamega. Crashed 2.36 and regn cld 1Q.36.
- VP-KAS DH.60G Moth (1911) [UK CofA 3571 issued 1.9.32] Regd 1.10.32 (CofR 19) to R Ussher & PO Mweiga, Nyeri (note: second name may be address). Crashed 16.10.32. Regn cld 7.33.
- VP-KAT DH.80A Puss Moth (2059) ex **G-AARF** Regd 12.6.33 (CofR 20) to Wilson Airways Ltd, Nairobi; named "Knight of the Garter". Regn cld 5.34 on sale to G Prudhomme, Uganda. Prudhomme was a French subject and it was required therefore to be placed on French register. In the event this was not progressed and it was next allocated **VP-KBM** 8.4.35 to Njoro Country Club (an owner invented by Prudhomme for registration purposes). This was not taken up but finally on 27.8.35 it was officially regd as **VP-KBO** to Njoro Country Club. Regn cld 1Q.36.

VP-KAY DH.80A Puss Moth (2076) ex **G-AAZU, VR-TAI** Regd 21.6.33 (CofR 25) to Wilson Airways Ltd, Nairobi. Damaged in accident at Kitale 1.2.39. Sold as spares to EW D'Olier 28.4.39. Regn cld as wfu 9.39. Either scrapped or possibly to KAAU as K3 or K17 (which remain unidentified).

VP-KBI DH.80A Puss Moth [2153] ex **VP-KAM**, Belgian Congo Regd 20.4.35 [CofR 35] to L Kaplan, Nairobi. Regd 25.5.35 [CofR 35] to SN Turner, Nyeri. Regd 3.7.36 [CofR 35] to East African Airways Ltd, Nairobi. Regd [CofR 35] 27.3.37 to George Blowers, Nairobi. Regd [CofR 35] 1.6.38 to Mrs Genesta May Long, Elementaika. Impressed into **KAAU** 9.39 (as either K3 or K17?).
